

CHAPTER I IACHR ACTIVITIES IN 2019

A. Strategic Plan 2017-2021


- 1. On March 22, 2017, the Inter-American Commission on Human Rights (IACHR) adopted its Strategic Plan for 2017-2021. Strategic Plan 21 is the principal institutional management tool establishing the priorities that the IACHR will pursue in order to successfully fulfill its mission and address the current and future challenges involved in upholding and protecting human rights in the Americas.
- 2. By weaving together its mandates, functions, and mechanisms, the IACHR defined the strategies that will guide its work in the coming years. For 2017-2021, the Inter-American Commission prioritized a series of topics and populations, some of which have been worked on by its Rapporteurships. Populations to be prioritized included: indigenous peoples; women; migrants; refugees; stateless persons; victims of human trafficking and internally displaced persons; Afro-decendants; children and adolescents; human rights defenders; persons deprived of liberty; lesbians, gays, bisexual, trans, and intersex persons; persons with disabilities; and older persons. The Plan looks at three priority thematic areas: the right to freedom of expression; economic, social, cultural, and environmental rights; and the right to memory, truth, and justice. The Strategic Plan also contains six cross-cutting themes: democratic institutionality; judicial independence and independence of the Public Prosecutors' Office, and access to justice; institutionality in human rights; security and violence; development and human rights; and gender equality and diversity.
- Since Strategic Plan 2017-2021 was adopted, there have been major achievements in each of the programs, as detailed in the First Partial Report on the Strategic Plan (with respect to 2017) and the Second Report (with respected to 2018), as well as in the Six-Month Progress Report for 2019. For instance, in the program to reduce the procedural backlog, one of the Commission's priorities, there have been all-time records in the number of petitions reviewed at the initial, admissibility, and merits stages. The Precautionary Measures Mechanism has been strengthened, resulting in more expeditious decision making and no more backlogs with regard to initial reviews. The Friendly Settlements Mechanism has also been boosted, as a result of which there has been an increase in expressions of interest and in the number of agreements signed. As for monitoring, work has been ordered by country and by issues; new standards have been set; and the Commission's presence on the ground has expanded through more working and on-site visits, more thematic reports, press releases, and other products analyzing the human rights situation in the region. Technical cooperation, training, and promotional activities have all been bolstered, as well as ties to civil society, universities, national human rights institutions, and other international, regional, and subregional human rights organizations. New methodologies and initiatives for following up on IACHR recommendations have been developed, along with new special mechanisms for monitoring the implementation of recommendations. The IACHR has appeared more frequently before both OAS and United Nations bodies, and has broadened its presence in the countries of the region by holding itinerant ("roaming") sessions and conducting numerous working and assistance visits to the member states. All of that reflected institution-building within the IACHR thanks to results-based management and frequent dialogue and participatory consultations with users of the inter-American human rights system. The ultimate goal of this strategy is to make that system more effective, thereby enhancing the protection and promotion of human rights for everyone in the Hemisphere.
- 4. As regard 2020, the IACHR intends to continue implementing the Plan to achieve the targets and objectives proposed in each of the programs and strategic objectives, albeit with a special emphasis, above all, on reducing the procedural backlog; implementing fast-track mechanisms in crisis situations;

reinforcing collaboration with the Caribbean and Central America; technical assistance to States with implementing policies with a human rights perspective; bolstering the capacity of State actors and civil society to protect and defend the human rights of groups at greatest risk; and strengthening and redefining I.T. systems.


B. Structure of the Executive Secretariat


- 5. In 2019, under Program 17 of the Strategic Plan 2017-2021, the IACHR set about improving the administrative structure of its Executive Secretariat. The new structure was officially instituted on September 24, 2019 with the publication by the OAS Secretary General of Executive Order 19-01. The new administrative structure divides the Executive Secretariat into the following major areas: the Assistant Executive Secretariat for Petitions and Cases; the Assistant Executive Secretariat for Monitoring, Promotion, and Technical Cooperation on Human Rights; the Office of the Chief of Staff; the Office of Specialized Counsel; and the Office of Administration and Institutional Matters. The new structure reflects the Strategic Plan's goal of establishing a "more integrated and horizontal administrative structure."
- 6. The new organizational structure of the Executive Secretariat incorporates elements of results-based management and modernizes its operations, establishing a more horizontal and agile organizational chart. Instead of having five departments and five levels of hierarchy, it will be structured around two Assistant Executive Secretariats, two Specialized Offices and three levels of hierarchy. The changes cater to a long-standing need to endow the Executive Secretariat with an institutional structure. The new administrative structure, the doubling of the Regular Fund budget allocation, and the financial sustainability plan constitute major achievements in terms of the institutional stability of the IACHR.




C. Periods of Sessions of the IACHR held in 2019

- 7. During 2019, the IACHR held four periods of sessions, three of which took place away from headquarters. Holding sessions away from headquarters enables the IACHR to bring the mechanisms for defending, protecting, and promoting human rights closer to victims and peoples within its sphere of competence. It also expands the Commission's public presence in the region and fosters democratization of access to the inter-American human rights system.
- 8. During those periods of sessions, in which 108 hearings were held, the IACHR monitored and highlighted a significant number of human rights situations. The hearings dealt with issues related to the monitoring of regional and some subregional situations, and of 22 countries in particular: Argentina, The Bahamas, Bolivia, Brazil, Canada, Chile, Colombia, Cuba, Dominican Republic, Ecuador, El Salvador, Guatemala, Haiti, Honduras, Jamaica, Mexico, Nicaragua, Peru, Trinidad and Tobago, United States, Uruguay, and Venezuela. They also addressed new trends in human rights and follow up on recommendations issued by the IACHR. Some 330 civil society organizations took part in the hearings.





9. The hearings covered 13 topics and 6 priority cross-cutting themes mentioned in the Strategic Plan. Worth undescoring, in this regard, is the trend toward greater intersectorality in the topics addressed in the hearings.



- 10. In those periods of sessions, the IACHR decided to convene six hearings on its own initiative (ex officio). They were: Good Practices on Prevention, Investigation and Protection of Human Rights Defenders in the Region," "Human Rights, Development, and Freedom of Association," "Monitoring of Precautionary Measures 70-19; 83-19; 102-19; 115-19; 150-19; 178-19; 181-19; 250-19," "Environmental Protection in the Amazon and the Rights of Indigenous Peoples in Brazil," "Missing and Murdered Indigenous Women and Girls in Canada" and "The Human Rights Situation in the Context of Social Protest in Chile."
- 11. In addition, during the four periods of sessions, 141 working meetings were held on precautionary measures, cases and matters being addressed in friendly settlement proceedings, monitoring of recommendations, cases being processed and topics relating to 17 countries: Argentina, Brazil, Chile, Colombia, Dominican Republic, Ecuador, Guatemala, Haiti, Honduras, Jamaica, Mexico, Nicaragua, Panama, Paraguay, Peru, United States, and Venezuela. Parallel to those meetings, there were also numerous bilateral meetings with civil society and with States in the region to address a variety of human rights matters of particular interest.




D. Resolutions Adopted

In 2019, the IACHR adopted four resolutions: Resolution 1/19, "Initial Review of Petitions," of October 29, 2019, in which it decided to re-examine 348 of the 2,734 rejected petitions, for which reexamination had been requested and to give notice of its final decision on each individual petition via the regular channels during first-half 2020 and to reject 2,386 of those petitions; Resolution 2/19, of September 22, 2019, "Creation of the Inter-American Commission on Human Rights Impact Observatory," as a collaborative platform with the objective of reflecting, systematizing, and making visible the impact of its actions in the defense and protection of human rights in the Hemisphere; Resolution 3/19, "Principles governing public Memory policies in the Americas," of November 9, 2019, adopted in light of the need to develop guidelines for crafting, drawing up, and implementing public Memory policies commensurate with the obligation of States to provide truth, justice, reparation and measures to prevent the repetition of serious human rights violations; Finally, Resolution 4/19 "Inter-American principles on the human rights of all migrants. refugees, stateless persons and victims of trafficking in persons" approved on December 7,2019, for which the IACHR considered it important to consolidate and deepen guidelines and guidelines for the design, development, implementation and evaluation of public policies for the protection and promotion of the rights of migrants, refuges, stateless persons and in situations of displacement and mobility in accordance with state obligations and inter-American standards in this subjects.

E. Press Releases Issued in 2019

14. In 2019, the Inter-American Commission on Human Rights (IACHR) published 346 press releases, 25% more than in 2018. They dealt with priority topics in the region and contain pronouncements regarding worrisome human rights situations in the Americas as well as acknowledgments of best practices pursued in some States. Through this mechanism, the Commission addressed the 13 priority issues and 6 cross-cutting themes identified in the Strategic Plan and pronounced on various aspects of the human rights situation in the region as a whole and, specifically, in 26 countries: Argentina, The Bahamas, Barbados, Bolivia, Brazil, Canada, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Guatemala, Haiti, Honduras, Jamaica, Mexico, Nicaragua, Panama, Paraguay, Peru, Trinidad and Tobago, United States, Uruguay, and Venezuela. The press releases also addressed matters relating to technical cooperation and activities to promote human rights in the region. They also served to highlight major aspects and achievements in the way the IACHR goes about its work.





- 15. Through joint press releases, the IACHR also stepped up its collaboration with the United Nations human rights system and other regional human rights systems and subregional mechanisms. Thus, 37 press releases were issued jointly with other entities, such as the Inter-American Court of Human Rights, the Office of the United Nations High Commissioner for Human Rights, the MERCOSUR Institute of Public Policies on Human Rights (IPPDH), and so on.

F. The Social Participation Agenda

- 17. In 2019, the IACHR continued its practice of establishing periodic channels of dialogue with civil society and the academic sector.
- 18. Approximately 330 civil society organizations took part in the Public Hearings held in connection with the 171st, 172nd, 173rd, and 174th periods of sessions in Bolivia, Jamaica, the United States (headquarters), and Ecuador. Open meetings were also conducted with civil society during the periods of sessions, in which the organizations contributed information regarding the human rights outlook in the countries of the Americas. Holding sessions away from headquarters increased access to the IACHR for civil society organizations from different parts of the region, expanding the role of actors involved in the inter-American human rights system.
- 19. During the on-site visit to El Salvador, from December 2 to 4, 2019, the IACHR held an open meeting with Salvadoran civil society organizations, as well as numerous meetings with organizations working on issues that were prioritized in the visit. In 2019, the IACHR also conducted a large number of virtual meetings with civil society in Brazil, Colombia, El Salvador, Nicaragua, and Venezuela, regarding the work being done by its various mechanisms.
- 20. The IACHR also met with civil society during its country visits in 2019, which included visits to Argentina, Barbados, The Bahamas, Bolivia, Chile, Costa Rica, Ecuador, El Salvador, Haiti, Honduras, Jamaica, Mexico, Panama, Trinidad and Tobago, the United States, and Uruguay.
- 21. In addition, the Commission met with civil society organizations during the 49th regular session of the OAS General Assembly, held in Medellín, Colombia, and during activities carried out within the framework of the United Nations Human Rights Council, in Geneva, Switzerland.
- 22. The IACHR convened civil society organizations to take part in the second face-to-face public consultation of the Memory, Truth, and Justice Unit in Sucre, Bolivia, on February 14, 2019, as part of the ongoing participatory process of developing that Unit's work. Participating in that meeting were 30 people from 7 countries: Bolivia, Brazil, Colombia, Costa Rica, El Salvador, Peru, and the United States.
- 23. As regards thematic reports, the IACHR continued to prioritize and honor its commitment to hold public consultations as a way to elicit inputs from all relevant actors, including civil society organizations, whose contributions are vital for drawing up these reports. In 2019 the IACHR drew up questionnaires to be filled in by civil society with input for reports on "Domestic systems for implementing IACHR decisions," "Economic, social, cultural, and environmental rights of indigenous and tribal Afrodescendent peoples in El Salvador, Honduras, Guatemala, and Nicaragua," "Corruption and human rights in America," "The economic, social, cultural, and environmental rights situation of Afrodescendants in the Americas," "Privatization of security: impact of private security on human rights," Inter-American principles on the human rights of migrants, refugees, and other persons in the context of mixed migratory movements," and "National systems for protecting the rights of older persons in America."
- 24. For the 2019 IACHR Annual Report, the IACHR again invited civil society organizations and other actors in the 35 OAS member states to send information regarding the human rights situation in the region as input for Chapters IV.A., IV.B, and V.
- 25. Using its special monitoring mechanisms, the IACHR continued promoting ongoing dialogue with civil society organizations and with victims and family members of victims of human rights violations. Notable in that connection is the Commission's ongoing presence in Mexico and its periodic meetings with family members in the Ayotzinapa case, within the framework of the Special Monitoring Mechanism (MESA), Likewise, in the Dominican Republic, the IACHR held videoconferences and meetings, and conducted surveys with civil society in connection with the Round Tables on the Implementation of Public Human Rights

Policies in that country, as part of a strategy implemented in response to a request by civil society. With regard to the Special Monitoring Mechanism for Nicaragua (MESENI), the IACHR underscores its collaboration and steady exchange of information with civil society organizations, as well as its strategy of providing technical assistance and capacity-building for Nicaraguan civil society organizations, through tailored training courses for them in Nicaragua, Costa Rica, Miami, and Washington, D.C. The recently launched Special Monitoring Mechanisms for Venezuela (MESEVE) aims to work closely with various key players, including civil society organizations. Finally, the Special Technical Counseling Committee (MESAT) for compliance with the human rights recommendations of the IACHR, installed in Honduras, also plans to conduct activities open to civil society participation.

- 26. In connection with its 60th anniversary and pursuant to its Strategic Plan 2017-2021, the IACHR continued developing ties and cooperation partnerships with academic bodies throughout the region. To that end, it called upon universities and other academic institutions specializing in human rights to join the "Academic Network Specializing in Cooperation with the IACHR", with a view to providing technical support for the Commission's work, especially the tasks performed by its Special Rapporteurships. As this Report went to press, 64 applications to join that Netwrk had been received from universities and other academic institutions.
- 27. Meanwhile, cooperation continues with universities, other academic and research institutions, and civil society organizations. In all, eight cooperation agreements were signed. These were with the following institutions: Universidad del Magdalena, Colombia; Pontificia Universidad Javeriana de Cali, Colombia; the Law Faculty at Rutgers Universith, Uited States; Instituto Ibero-Americano para la Paz in The Hague; the Law Faculty of Universidad de Buenos Aires, Argentina; Fundación Universitaria del Área Andina, Colombia; University of Monterrey, Mexico, and OXFAM International.
- 28. With a view to expanding civil society participation in its activities and proposing new mechanisms and channels for such participation, the IACHR invited interested organizations to fill in a questionnaire posted on its website. The inputs received via the questionnaire will be vital for drawing up a public document on the policy to be pursued for civil society participation in IACHR activities, as envisaged in Program 12 of the Strategic Plan 2017-2021. The suggestions made by civil society will also be key inputs for developing dissemination and training materials for participation, with a view to bolstering the inter-American human rights system as a pillar and joint commitment of the Americas.

G. Technical Cooperation

- 29. The IACHR's work revolves around three pillars: the individual petitions system; monitoring of the human rights situation in the member states; and counseling and technical cooperation with States. Using that structure, the Commission considers that, within the context of protecting the rights of all persons under the jurisdiction of the States of the Americas, it is especially important to pay particular attention to the communities and groups that, historically, have borne the brunt of discrimination and exclusion.
- 30. Within that framework, the IACHR engages in activities providing assistance and technical cooperation to member states, helping them to develop and pursue public policies with a human rights approach and offering ideas and responding to specific requests made by States. The main focus is on forging greater familiarity with, and use of, the inter-American human rights system by States, encouraging the application of inter-American standards, and fostering compliance with the system's recommendations.
- 31. Indeed, one of the priorities that the IACHR selected for 2019 was to strengthen its capacity to provide technical cooperation with member states, regional organizations, and other institutions. Thus, throughout the year, the IACHR moved ahead both with the drafting of instruments and inputs to support those responsible for formulating public policies and with the consolidation of the ties needed to provide technical assistance and backing for the States' institutional strengthening strategies, while at the same time developing cooperation with other institutions.

- 32. Especially noteworthy in this area was the Commission's adoption of a first report on "Public Policies with a Human Rights Approach" designed to provide an effective tool for those responsible for planning, formulating, implementing, and monitoring or evaluating public policies. The report places at their disposal inter-American principles and standards in that field, along with a set of practical guidelines to shape States' actions at the various stages of a human rights-oriented public policy cycle. In 2020, the IACHR plans to continue reinforcing its public policy work, providing technical assistance to the States in the region based on the standards and recommendations embodied in this Report.
- 33. During the year, the IACHR published another report entitled "Internal Displacement in the Northern Triangle of Central America: Public Policy Guidelines." Again, the purpose of this document is to provide a practical tool for government officials in charge of compliance with human rights obligations as well as for representatives of civil society organizations that work in promotion and protection of the rights of internally displaced people and that demand that the State adopt measures and puvblic policies to respond to this troubling situation.
- 34. As part of that same technical assistance strategy, the IACHR produced a "Practical Guide: Guidelines for the formulation of public policies on internal displacement". This Guide is an attempt to provide a didactic presentation of the principal recommendations for the formulation of public policies to address this human rights issue,
- 35. As part of this same institutional strengthening and technical cooperation goal, another novel training initiative of the IACHR in 2019 is worth highlighting. This was the International Course on Public Policies in Human Rights that the IACHR organized in partnership with the MERCOSUR Institute of Public Policy and Human Rights (IPPDH). The partly face-to-face and partly online six-month course was for 100 State officials responsible for public policy design, direction, implementation, and evaluation; members of civil society organizations and movements, academics, and society at large.
- 36. Finally, attention should be drawn to the work carried out by the IACHR with the Technical Unit of the Justice Sector of El Salvador pursuant to a request for technical cooperation to broaden knowledge, reflection, and dialogue in the judiciary on transitional justice processes n that country. To provide that technical cooperation, the IACHR organized 64 hours of training through a workshop comprising four consecutive modules between August and November 2018. The modules designed for 70 participants in the El Salvadoran judiciary addressed key issues in transitional justice, with the help of IACHR specialists and international experts.
- 37. The IACHR wishes to express its will and readiness to provide technical cooperation to States, regional organizations, social organizations, and other institutions for the purposes of institution building and formulation, implementation, and assessment of public policies on strengthening and observance of the human rights of internally displaced persons, based on the inter-American standards.
- 38. In the course of 2019, 21 new inter-agency cooperation agreements were signed, including 8 with universities. The complete list of institutions is as follows: The Attorney General's Office (*Procuración General de la República* PGR), Colombia; the Executive Commission for Caring for Victims of the United Mexican State; the Benito Juárez University in Oaxaca; Universidad Metropolitana, Ecuador; Guatemalan Human Rights Ombudsman's Office; the National Council of the Federal Public Prosecutors' Office, Brazil; the Federal Public Prosecutors' Office, Brazil; the Law Faculty at the University of Oklahoma; Mexico's National Council against Discrimination (CONAPRED); teh Public Prosecutors' Office, Chile; Torcuato Di Tella University, Argentina; Colombia's Truth, Peaceful Coexistence, and Non-Repetition Commission; the International Land Coalition; the Law Faculty at Universidad Nacional de Córdoba; the Los Ángeles Law Faculty at the University of California: Brown University; the Labor Public Prosecutors' Office of Brazil; the Catholic University of Peru; the Institute for Social Responsibility and Human Rights (IRRESODH); Save the Children; the Latin American and Caribbean Network for the Defense of Children and Adolescents (REDLAMYC); and the Colombian State.

39. Under the aegis of those agreements, advances are being seen with the expansion of the fellowship program and of the associate staff program, as well as with training, promotion, and academic research activities. During this period, 7 professionals joined the Executive Secretariat under the Associated Personnel Program.

H. Activities of the IACHR in connection with the Inter-American Court of Human Rights

- 40. On November 6 and 7, 2019, the Inter-American Court of Human Rights and the IACHR held their joint Third Inter-American Human Rights System Forum at the Catholic University of Ecuador in Quito sponsored and organized by the Office of the Procurator-General; of Ecuador.
- 41. The theme of the Third Inter-American Human Rights System Forum was about celebrating the 60th anniversary of the Inter-American Commission on Human Rights and the 40th anniversary of the Inter-American Court of Human Rights. The idea was to reflect on the historical impact of their work and to trigger debate about present and future challenges given the current regional context, about how effective the system is, and about other key topics on the human rights agenda in America, through a constructive exchange of views among States, civil society, international organizations, universities, social and trade union movement, and the general public.
- 42. Worth noting is that, in connection with the Forum, the objective of the Inter-American Conference on Public Policies was to establish a dialogue with State authorities, civil society representatives, academia, experts, and regional and international organizations with a view to jointly identifying progress made and still pending challenges with formulating and implementing public policies with a human rights objective in the region.

I. Relations with the Political Organs of the OAS

- 43. One of the functions of the IACHR is to provide advisory services to States on human rights matters; these services are provided through the IACHR's ties with the political bodies of the OAS: the General Assembly (GA) and the Permanent Council (PC) and its Committees, particularly the Committee on Juridical and Political Affairs (CAJP) and the Committee on Administrative and Budgetary Affairs (CAAP). The IACHR lends support to OAS political organs in order to promote the necessary minimal human rights standards in resolutions, declarations, treaties, conventions, and other Inter-American instruments. It also maintains relations with other areas of the OAS.
- 44. In 2019, the IACHR was represented continuously at meetings of the OAS Permanent Council, the Committee on Juridical and Political Affairs, and the Committee on Administrative and Budgetary Affairs. The IACHR also responded to requests to submit information to the political organs of the Organization regarding implementation of resolutions, as well as other specific requests by the Member States, with the participation of the Commissioners, the Executive Secretary, Special Rapporteurs, and human rights specialists of the Executive Secretariat. Following is a list of those presentations:

- 45. In 2019, 16 meetings were held to review portfolios of petitions, cases, precautionary measures, and friendly solutions, and to follow up on recommendations with the following States: Uruguay (April 1); Canada (April 17; Ecuador (May 16 and 17)); Colombia (June 4 and 5 and November 21); Nicaragua (July 30); Argentina (August 13 and 14, October 31 to November 1 and December 11); Bolivia (September 3 and 4); Costa Rica (September 19 and 20); Chile (October 3 and 4); Panama (November 21); Guatemala (December 9 to 11), and Brazil (December 16 to 18).
- 46. In connection with the 49th Regular Session of the OAS General Assembly, the IACHR held bilateral meetings with the Ministers of Foreign Affairs or Heads of Delegation; and with the delegations of the member states and observer countries. It also met with civil society organizations.

J. Activities of the IACHR with Regional and Universal Human Rights Bodies

47. The IACHR further developed its collaboration with the United Nations human rights system on several fronts. On the one hand, it continued various previous practices, such as delivering inputs for the Universal Periodic Review of Bolivia, El Salvador, Grenada, Guyana, Honduras, Jamaica, Panama, and the United States and it welcomed United Nations special rapporteurs. representatives of field offices of the Offices of the United Nations High Commission for Human Rights (OHCHR), and a UNICEF representative to take part in hearings during its 171st and 172nd periods of sessions. In particular, an ex officio public hearing took place at the 172nd PS in collaboration with the United Nations Special Rapporteur on the Rights to Freedom of Peaceful Assembly and of Association, Clément Voule, on the subject of "Human rights, development, and freedom of association." In addition, during the same period, 17 press releases were published, along with 8 joint letters with OHCHR or special procedures of the United Nations system.

- 48. Since 2018, the IACHR has been participating on a more regular basis in sessions of the Human Rights Council in Geneva. In 2019, it stepped up that form of collaboration. For the first time, the IACHR took part in the high-level segments of the sessions, on February 27; on that occasion, Commissioner Joel Hernández gave a presentation focusing principally on the situation in Nicaragua. The IACHR also participated in the inter-active discussion of the Human Rights Council on March 7, with a speech on the situation in Nicaragua. Furthermore, on March 19, the IACHR held a parallel meeting on the situation in Nicaragua and the work of the Special Monitoring Mechanism for Nicaragua (MESENI), in which 18 delegations from the Americas, Asia, and Europe took part.
- 49. Commissioner Hernández was also one of the speakers at two other parallel meetings, both about Nicaragua. One of of those meetings took place on March 5 and was entitled "The human rights crisis in Nicaragua: an analysis based on the findings of the Interdisciplinary Group of Independent Experts for Nicaragua (IGIE-NI)." It was organized jointly by Amnesty International and the Center for Justice and International Law (CEJIL). The other, organized by Human Rights Watch, took place on March 7 and was entitled "The role of the Human Rights Council in putting an end to the human rights crisis in Nicaragua."
- 50. On March 21, 2019, the Human Rights Council adopted Resolution 40/2 on the Promotion and Protection of Human Rights in Nicaragua, which expresses grave concern regarding serious human rights violations and abuses since 2018; calls upon the Government to release all those arbitrarily or illegally detained; deeply regrets the decision by the Government of Nicaragua to suspend the mission of the Interdisciplinary Group of Independent Experts in Nicaragua (GIEI-Ni) and the Special Follow-up Mechanism for Nicaragua (MESENI), and calls upon the Government to resume its cooperation with the Office of the United Nations High Commissioner for Human Rights, the Organization of American States and the Inter-American Commission on Human Rights.
- 51. During the 42nd session of the Human Rights Council, the IACHR took part as a guest in the high-level panel discussion of the report by the High Commissioner on the human rights situation in Nicaragua. The Commission also took part in the inter-active dialogue on the situation of migrants in the region; presented comments on the report of the Special Rapporteur on Memory, Truth, and Reparation; participated in parallel meetings on Nicaragua and Brazil; and met with civil society and OHCHR representatives.
- 52. Notably, in 2019 the IACHR <u>signed a Roadmap with the United Nations Special Procedures</u> for broadening and boosting cooperation. In the course of the year, there were 23 joint initiatives, including communiques, letters, and public activities. In addition, a methodology was developed and applied for monitoring implementation of the actions envisaged in the Roadmap.
- 53. On October 21-22, 2019, the IACHR took part in the Workshop on Racism, Racial Discrimination, Xenophobia and Other Related Forms of Intolerance organized by OHCHR in Geneva, Switzerland. The workshop brought together the universal human rights system, regonal mechanisms, States, civil society, and academia to discuss the principal challenges in this field and to work out strategies for cooperating with regional human rights mechanisms and the universal system. That workshop completed the series of consultations on that topic initiated in 2018. In addition, on October 23, the IACHR took part in the annual meeting of focal points of regional human rights mechanisms and OHCHR.
- 54. In the year covered by this report, the IACHR proceeded with its second year of implementing the Joint Action Mechanism to Contribute to the Protection of Human Rights Defenders in the Americas, with OHCHR, following the progress made in 2017 with crafting its draft agenda and conducting public consultations and the first year of implementation in 2018, when the joint action mechanism was consolidated with specific proposals for actions to be undertaken in five priority areas: (1) Joint studies, (2) Monitoring and protection, (3) Advocacy, (4) Promotion, and (5) Technical assistance.
- 55. To ensure that those measures are carried out, it was agreed that the two organs would periodically exchange information for jointly analyzing issues and situations of special concern, as well as steps to to ensure effective and timely protection for any defenders who might be at risk. In addition,

progress was made with the drawing up of three biannual action plans with OHCHR national offices in Honduras, Guatemala, and Mexico.

- 56. In 2019, the two bodies took a series of joint steps, including joint national and regional pronouncements on situations of mutual concern; joint participation in monitoring, promotion, and training activities; and increased sharing of information and assessments of the human rights situation of defenders in the region, including important information in relation to precautionary measures.
- 57. Within the framework of the Mechanism, the IACHR spearheaded the production of press releases and four-monthly reports on the situation of human rights defenders in the region. On May 30, a press release was published, entitled "IACHR and Regional Branches of the OHCHR Concerned about the Situation of Human Rights Defenders in the Americas in the First Four Months of 2019," adopted by the OHCHR offices in Guatemala, Mexico, Panama, Chile, and Honduras. On November 7, a second press release/report was published, entitled "IACHR and UN Human Rights Presences Once Again Call for the Creation of a Safe, Favorable Environment for Human Rights Defenders in the Americas" and signed by the OHCHR in Colombia, Guatemala, Mexico, Panama, Haiti, Chile, and Honduras.
- 58. In the period covered by this report, information was also shared regarding the situation of human rights defenders. In particular, information was shared regarding the increased number of murders in Mexico and used to compile statistics on the number of attacks thus far. In addition, the IACHR's Rapporteurship on Human Rights Defenders proceeded to develop inputs for the document produced by the OHCHR branch in Mexico, containing a diagnostic assessment of the modus operandi of the National Protection Mechanism. That document points to weaknesses in the way the National; Mechanism functions and presents a series of recommendations and guidelines on how to improve it. In connection with the Mechanism, information was shared about the situation of leaders and activists in connection with the protests in Honduras associated with the national strikes in the health and education sectors. In the same vein, on May 6, the IACHR and the South America branch of OHCHR sent a joint communique to the Peruvian State declaring their support for the adoption by the Ministry of Justice of the protocol on protection for human rights defenders.
- 59. As regards promotion, in January 2019, the IACHR and the Mexican branch of OHCHR conducted a joint training course in Chihuahua, Mexico. As for joint studies, the first joint diagnostic assessment study of the situation of human rights defenders in the Americas is nearing completion. Likewise, progress has been made with gathering preparatory material for a best practices manual.
- 60. Apart from its coordination with the unversal human rights system, in 2019 the IACHR also continued its cooperation with regional and subregional human rights systems. In particular, the IACHR followed up on cooperation with Mercosur's Public Policies Institute in connection with the International Course on Public Policies in Human Rights. The course, with its 100 participants, targets state officials responsible for public policy design, direction, implementation, and evaluation; members of civil society organizations and movements, academics, and society at large. The first version of the course ended in 2019 and a second version began.

K. Follow-up on Recommendations

61. In 2019, in connection with the Special Program for Monitoring Recommendations (Program 21) of the Strategic Plan 2017-2021, the IACHR took steps to consolidate the Monitoring of Recommendations and Impact Section established in 2018 to coordinate follow-up to recommendations issued by the IACHR through its various instruments and tools and to assess the impact and effectiveness of its projects and programs. Since September 2019, the Monitoring of Recommendations and Impact Section has been overseen directly by the Executive Secretary (Executive Order No. 19-01), which will facilitate expansion of the monitoring work performed by the whole of the IACHR Executive Secretariat and make it more integral, cross-cutting, and coordinated among all its areas.

- 62. Pursuant to Article 48 of the Rules of Procedure of the IACHR, in 2019 the Commission continued to promote efforts to strengthen the processes for keeping track of its recommendations. In particular, the IACHR made headway with crafting methodologies, which led to the adoption of General Guidelines on the Follow-up of Recommendations and Decisions of the Inter-American Commission on Human Rights, a technical tool to ensure concrete and specialized follow-up to each case. In implementing those Guidelines, the IACHR fostered an effective rapprochement among the different users of the inter-American system with a view to forging paths toward real compliance with Commission's recommendations, as well as with the various agreements entered into by the parties. Likewise, at the 173rd period of session, the Commission adopted the Resolution on the Creation of the Inter-American Commission on Human Rights Impact Observatory. This project seeks to build a collaborative platform with the objective of reflecting on, systematizing, and highlighting the impact of its actions in the defense and protection of human rights in the Hemisphere.
- 63. In 2019, progress was also made with developing the Inter-American Recommendations Monitoring System (SIMORE). This is an online I.T. tool systematizing the recommendations made by the Commission through its various mechanisms: adopted friendly settlement agreements, annual reports (Chapter IV.B), published reports on the merits, country reports, thematic reports, and precautionary measures granted. SIMORE lets users of the inter-American human rights system remit information regarding measures adopted by States to comply with those recommendations. In addition, SIMORE is an accountability, transparency, participation, and access to information mechanism that facilitates follow-up on recommendations and boosts ability to oversee measures and promote compliance with international obligations. The IACHR highlights the fact that, during the OAS General Assembly on June 28, 2019, the States of the Hemisphere reaffirmed their appreciation of the efforts undertaken to implement this system within the framework of the IACHR Strategic Plan 2017-2021 (Resolution AGAG/RES. 2941). SIMORE is still at the testing stage, which includes consultations with various kinds of users (government officials, members of society, academics, and so on). It is expected to be launched in the first quarter of 2020.
- 64. Within the framework of its Strategic Plan 2017-2021, the IACHR has encouraged the establishment of special mechanisms to follow-up on implementation of its recommendations as a novel practice in the international human rights law context. For the IACHR, such mechanisms foster a more holistic analysis of the IACHR's decisions and recommendations; facilitate the provision of up-to-date information to the international community regarding a particular situation or concrete case; add to the Commission's presence in-situ; encourage systematic and periodic monitoring of priority issues; and expand the scope of dialogue with the parties and the quest for solutions reached through consensus, among other benefits. All that is conducive to in-depth and specialized monitoring by the Commission of compliance with the commitments and obligations entered into by member states with respect to human rights.
- 65. In 2019, the IACHR promoted <u>dissemination of the outcomes of these Mechanisms</u> the establishment of the <u>Technical Support Group (GAT)</u> for the Ayotzinapa Affair installed in Mexico City, in the new stage of the Special Monitoring Mechanism (MESA); the new national stage of the Working Group on Implementation of Human Rights Policies in the Dominican Republic; the new phase of the <u>Special Monitoring Mechanism for Nicaragua (MESENI)</u>, working out of IACHR headquarters; the establishment of the <u>Special Monitoring Mechanisms for Venezuela (MESEVE)</u>; the Special Technical Counseling Committee (MESAT) for compliance with the human rights recommendations of the IACHR, installed in Honduras; and dialogues geared to establishing new cooperation mechanisms with member states, including <u>Haiti</u>, for follow-up and implementation of the IACHR's recommendations.

Special Follow-Up Mechanism on the Ayotzinapa Case (MESA)

66. As soon as the IACHR heard the denunciations of the disappearance of 43 teacher training college students in Mexico, it adopted Precautionary Measure 409-14 and asked the State to look and care for the victims and investigate what happened. Later, by agreement with the State and representatives of family members of the victims, the IACHR established an Interdisciplinary Group of Independent Experts (GIEI), which lent technical assistance to the state authorities and submitted two reports containing

recommendations to the State. Subsequently, the Commission deemed it necessary to establish a Special Monitoring Mechanism on the Ayotzinapa case (MESA) to track implementation of the recommendations made by the GIEI. That Mechanism has issued two reports containing recommendations to the Mexican State regarding core aspects of the precautionary measure.

- 67. In 2019, at the request of the State and family members of the victims, the MESA came up with a new Work Plan, to continue follow-up on the recommendations contained in the precautionary measure and reinforce the Mechanism by providing technical advice through the Technical Support Group (GAT) comprising Mexico-based staff of the Executive Secretariat and international experts. The ongoing presence of the IACHR team in Mexico has made it possible to stay in close contact with the parents of the disappeared youths and has facilitated more frequent talks with authorities, representatives, and civil society organizations involved with the precautionary measure, so as to keep more detailed, first-hand track of recommendations relating to efforts to look and care for the victims and investigate what happened and to the adoption of structural and non-repetition measures.
- 68. As regards international experts, the Group included former members of the Interdisciplinary Group of Independent Experts (GIEI), Ángela Buitrago and Francisco Cox, who took part as consultants providing technical advice on criminal investigation matters. The Mechanism and, above all, the Technical Support Group, carried out the Work Plan activities in coordination with the Truth and Access to Justice Commission for the Ayotzinapa Case established by the Mexican State to provide family members and their advisors with the material and human resources needed for them to assist as co-plaintiffs with the investigations. In going about its work, MESA personnel, from headquarters or in situ, attended all regular and special meetings of the Truth Commission to which it was convened. In addition, it requested that special meetings be convened.
- 69. In 2019, the Mechanism kept track of the search activities and plans reported by the Presidential Commission and of the use of Lidar technology for those searches. In connection with the investigation, the Mechanism continued to read the criminal investigation file and was present at some of the procedures undertaken by the Presidential Commission. In addition, at the beginning of the year, it monitored the then still pending appointment of the Public Prosecutor Specializing in the case, until he was appointed. Noteworthy, too, in this period was the establishment of the Special Investigation and Litigation Unit for the Ayotzinapa case in the Office of the Attorney General of the Republic (FGR). The Technical Support Group worked with that Unit on a number of specific topics in the inquiries. As regards care for victims, the Mechanism followed up on the Care Protocol for the nine urgent cases referred to in meetings of the Presidential Commission, in coordination with representatives and health sector authorities, apart from meeting with authorities on the Executive Commission for Caring for Victims in order to ascertain how the Protocol was to be implemented.
- 70. With respect to structural measures, the GAT took part in roundtable discussions convened by the National Search Commission in order to come up with a Standardized Search Protocol. It is also worth noting that the team at headquarters and on the ground constantly supported the talks between groups of family members of the disappeared persons and State authorities on establishing the Special Forensic Identification Mechanism, which began on May 9, 2019, at the period of sessions held in Jamaica, in connection with the public hearing on Enforced Disappearances and the Proposed Special Forensic Identification Mechanism for Mexico that was later adopted on December 5, 2019.
- 71. The Commissioners also paid visits to Mexico under the 2019 Work Plan. On January 15, 2019, Commissioner Esmeralda Arosemena de Troitiño and Commissioner Luis Ernesto Vargas Silva both attended the the launching of the Ayotzinapa Case Truth Commission. On March 24, 2019, Commissioner Luis Ernesto Vargas Silva was present at the relaunching of the National System to Search for Missing Persons. The Commissioners also visited Mexico from July 31 to August 1. The delegation traveled to Ayutla de los Libres, in the state of Guerrero, to visit Aldo Gutiérrez, a youth wounded on the night of September 26, 2014, and his family, and verified the medical care he is receiving and the home that was built for him. The

Commissioners also attended the meeting of the Presidential Truth Commission and met with authorities and relatives of the students. The IACHR issued press release No. 197/19 on that visit.

72. On September 25, 2019, the IACHR issued a statement in a <u>press release</u>, marking the fifth anniversary of the events that had occurred, voiced its concern at the absence of results in terms of justice and the truth, and deplored the lack of answers to questions about what happened and about who had been involved.

Special Monitoring Mechanism for Nicaragua (MESENI)

- 73. On June 24, 2018, the IACHR installed the MESENI to monitor compliance with the recommendations made by the IACHR following its visit to the country, based on the Preliminary Observations on that visit and the Report on "Gross Violations of Human Rights in the Context of Social Protests in Nicaragua." MESENI is also monitoring compliance with precautionary measures granted in that context and continues to monitor the human rights situation in Nicaragua in keeping with the IACHR's mandate.
- 74. Even though the Nicaraguan State announced on December 19, 2018 its decision to suspend the presence of MESENI and IACHR visits to the country, the Special Mechanism continues to monitor the human rights situation in Nicaragua from the Commission's headquarters in Washington D.C. and via working visits to other countries in the region, where there are Nicaraguans who have fled persecution in search of international protection. In 2019, the IACHR paid five MESENI-related visits. Thus, Commissioner Joel Hernández visited Costa Rica and Honduras between May 19 and 24, 2019. Later on, on June 17 and 18, Commissioner Esmeralda Arosemena, President of the IACHR, and Commissioner Antonia Urrejola, the Rapporteur for Nicaragua, visited Miami, in the United States. Commissioner Flávia Piovesan, the Rapporteur for Panama, paid a working visit to that county on September 16 and 17, 2019 and, finally, Commissioner Luis Ernesto Vargas visited Costa Rica from September 12 to 13, 2019.
- 75. On June 24, 2019, one year after MESENI began operating, the Inter-American Commission presented a <u>progress report on outcomes and impacts</u>. In that report, the IACHR came up with a positive assessment of the actions taken to protect the rights of the Nicaraguan population, preserve historical memory of what had happened in Nicaragua, and influence the path pursued by victims and their family members to elicit truth, justice, and reparation.
- 76. Based on its monitoring of the human rights situation, via the MESENI, the IACHR is putting together a strategy for providing a sustained and timely response to the human rights crisis in Nicaragua. During the period under review, the IACHR remitted seven requests to the Nicaraguan State for information regarding the specific situation of victims of State oppression and one Article 41 letter regarding the situation of persons deprived of liberty. In addition, the IACHR convened six public and one private hearing to garner specific information on human rights violations in the country.
- 77. Thanks to its visits and work done at headquarters, the MESENI collected 198 testimonies in 2019. Those testimonies and the information gathered via monitoring were vital for drawing up reports and publicizing the very serious situation in the country. During 2019, the Commission organized more than 25 video-conferences with civil society organizations and human rights defenders still in Nicaragua, with a view to obtaining first-hand information on the situation. Based on the above, the IACHR published 30 press releases on developments in the human rights crisis in Nicaragua in order to alert the international community to that situation. In addition, as of April 2019, the IACHR has been publishing monthly bulletins on MESENI activities with regard to Nicaragua.

Working Group (Mesa de Trabajo) on the implementation of human rights policies in the Dominican Republic

- 78. In keeping with its work plan, the IACHR installed the Working Group on the Implementation of Human Rights Policies in the Dominican Republic in 2018 and 2019.²
- 79. Initially, the Working Group held two meetings, with the participation of the Inter-American Commission on Human Rights, representatives of the State, Dominican civil society, and national and regional observers. The first meeting of the Group took place at the headquarters of the Organization of American States, in Washington, D.C., while the second was held in Santo Domingo, in the Dominican Republic.
- 80. Upon completing the first phase of the Working Group, the IACHR assessed progress and still pending challenges in Chapter V of the IACHR Annual Report for 2018. While still pending tasks and challenges were identified for attaining full compliance with the recommended measures, the Commission welcomed the actions taken by the State to resolve the human rights situation in the Dominican Republic, especially with respect to migration and the acquisition of nationality, policies for combating all forms of discrimination, and policies on Women's Rights and Gender Equality.
- 81. The second phase of implementation of the Working Group occurred in 2019 and consisted of four commitments entered into by the Dominican State: i) to hold a meeting with civil society, which took place on May 23, 2019³; ii) to fill in a questionnaire on human rights provided by the IACHR, in respect of which the IACHR received at Note dated November 6, 2019 from the Permanent Mission of the Dominican Republic to the OAS containing the State's response to the questionnaire⁴; iii) to conduct a training course in human rights for government officials, which was delivered on August 13 and 14, 2019, in the Dominican Republic⁵; and iv) to present a report at year's end in Washington, illustrating the progress made by the country with respect to human rights. That presentation took place on November 25, 2019 at the Commission's headquarters, with the participation of representatives of the State and Commissioner Luis Ernesto Vargas.

Special Technical Counseling Committee (MESAT) for compliance with the human rights recommendations of the IACHR

- 82. The Special Technical Counseling Committee (MESAT) for compliance with the Commission's human rights recommendations was installed in November 2019 to provide technical advice to the State of Honduras on implementing the IACHR's recommendations, pursuant to Article 41.e of the American Convention on Human Rights and in accordance with the Commission's mandate and the powers vested in it. The idea behind the installation of this Committee is to: provide technical assistance on human rights-related matters previously agreed upon between the parties; to offer technical assistance to Honduras with implementing IACHR recommendations; to follow up on compliance with the recommendations made by the IACHR in its Preliminary Observations and country reports; and to provide technical assistance with legislative initiatives and public policies on human rights.
- 83. The MESAT will conduct working visits to Honduras by the Rapporteur for that country and technical staff of the IACHR Executive Secretariat. Its work will be coordinated with the Honduran institutions

involved in the areas prioritized by the State within the MESAT framework, under the umbrella of the Human Rights Secretariat of Honduras. The MESAT will also engage in dialogue with Honduran civil society, as required by the products and activities envisaged in the Work Plan. Those products and activities will be developed and carried on with the help of thematic specialists in the IACHR Executive Secretariat.

84. The first working visit took place in November 2019, when the IACHR presented its report on "The Human Rights Situation in Honduras." Other activities carried out in connection with the MESAT included the launching of the report on "Violence and Discrimination against Women, Girls, and Adolescents: Challenges and Best Practices in Latin America and the Caribbean"; a training workshop on "Inter-American Standards: Violence and Discrimination against Women, Girls, and Adolescents"; and a training workshop on "Monitoring of IACHR Recommendations and Sharing Best Practices on SIMOREH and the Inter-American SIMORE."

Special Monitoring Mechanism for Venezuela (MESEVE)

- 85. To strengthen its monitoring in Venezuela and to respond promptly to the new challenges posed by the very serious human rights crisis in that country, in October the Commission installed the Special Monitoring Mechanism for Venezuela. (MESEVE).
- 86. The MESEVE will constantly monitor the human rights situation in the country and evaluate the political context and alleged violations with a view, as necessary, to prioritizing applications for precautionary measures, petitions received, admissibility reports, and reports on the merits. In addition, the MESEVE will follow up on the precautionary measures granted and the recommendations it makes to the State, and will encourage and support activities designed to strengthen Venezuelan civil society. The MESEVE will also work with other OAS and United Nations mechanisms to document the systematic violations of human rights in Venezuela.
- 87. The MESEVE plans to produce two reports in 2020, one on the overall human rights situation in Venezuela, and the other on the human rights situation of Venezuelan migrants. To gather material for the latter report, the MESEVE is planning on-site missions to a number of countries in the region that serve as transit or host countries for Venezuelan migrants.
- 88. It is important to point out that the IACHR has made a major effort to keep track of the human rights crisis in Venezuela. In 2019, the Commission issued 30 press releases on that country. Moreover, during IACHR periods of sessions in 2019, there were 13 thematic hearings on the human rights situation in Venezuela and the situation of Venezuelan migrants in the region. Likewise, the Commission began processing 90 petitions; sent 4 contentious cases to the Inter-American Court of Human Rights; granted 21 precautionary measures; and extended one precautionary measure granted in 2018.
