## Migrant and Refugee Children: Common Experiences and Collaboration for Human Rights Responses

**Lugar:** Torre I, auditorio 1 (no. 15 on the map)

**Objective:** The purpose pursued by the event is to make visible the contexts of profound violence experienced by children who must migrate from their countries and who, many times, are faced with journeys and migratory processes that threaten their physical and psychological integrity, being deprived of their rights to health, education, housing, and, of course, to live and be protected by their families, among many others. And also, to grant glances and experiences from the children themselves that allow to generate good practices and collaboration between States.

**Methodology:** For the development of the event, it is proposed the exhibition of three adolescents from the region, who will present their experiences, through which they intend to raise initiatives and good practices for the States, in a space of about 50 minutes. After that, two experts will give their opinions and suggestions in the matter with interventions of 25 minutes each, to finally close with the conclusions of the space.

## Inter-American Conference on Public Policies with a Human Rights Approach

## Causes of housing rights violations and DESCAs in informal settlements in Latin America and the Caribbean

**Objectives:** to find the causes and possible proposals in the context of rights violations in informal settlements in Latin America and the Caribbean. In the same way, to establish from a human rights perspective what would be the mechanisms of protection of the DESCAs, through the inter-American systems and the challenge of these before this problematic. As well as the linkage of States and communities for their protection.

**Methodology:** By means of the creation of questions and their possibilities of answer, in a participative way, to propose and debate the possible causes and solutions to approach the problematic in the context of violation of rights.

The objective is for each group to formulate 4 more questions, adding 5 whys in total including the initial question.

- Solutions: Once we have the 5 questions and 5 answers, the group must analyze the information and face each answer, must propose a possible action or strategy that can give solution to that cause.
- Plenary: Each group of the audience will share in plenary the questions posed with their respective answers. The objective is to identify which questions were repeated most frequently, and to classify the answers according to the number of repetitions that were given. In this way, the most frequently asked questions can be prioritized, revealing the most common causes identified by the participants.
- Analysis: In the same way, each group will present the solutions they proposed to each one of the causes, in order to reach a consensus as a group on which proposals should be taken to the IACHR and which can be developed.

## Afrodescendant Communities and indigenous people Involved in Territorial Dispossession and Environmental Racism

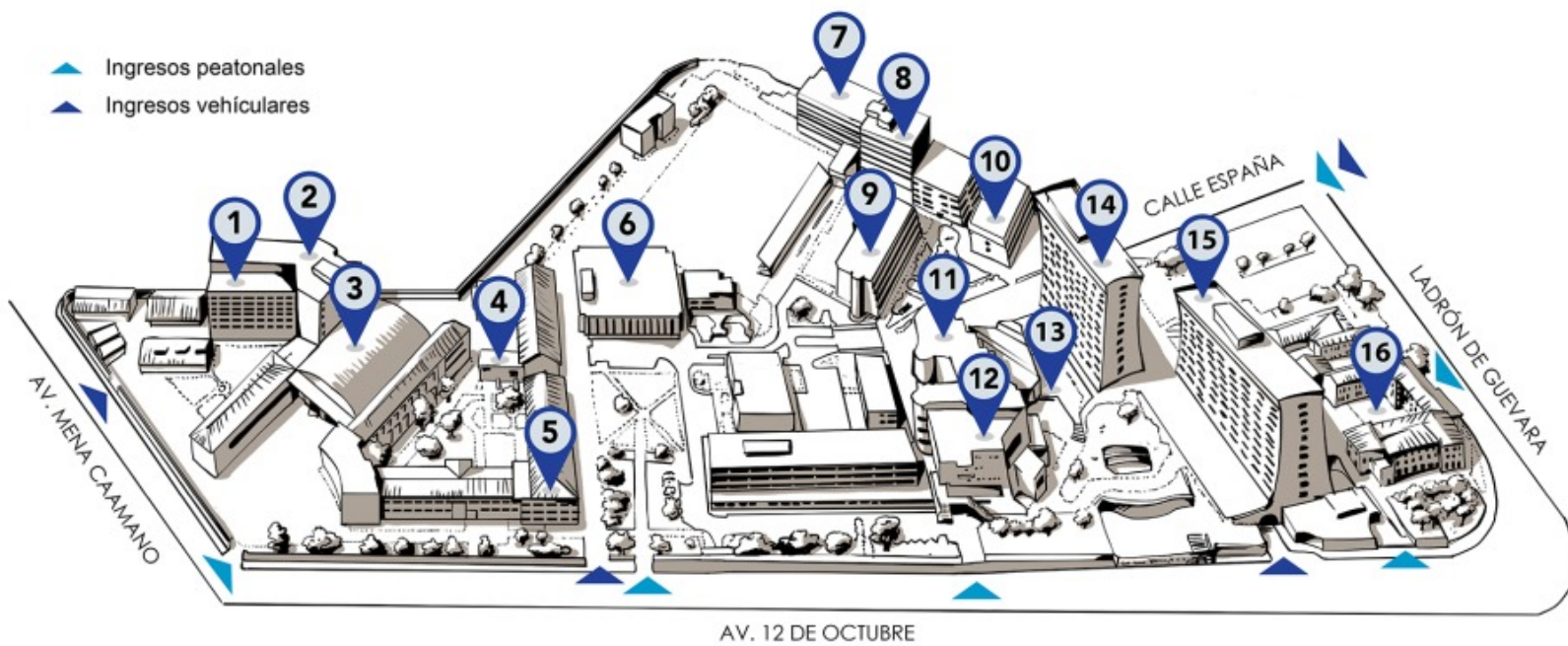
