Information he presented during his term of office was used in entities such as Amnesty International or different UN entities.

Participating as a member the Metagora Project (democracy and human rights measurement) Executive Committee, the Organization for the Cooperation and the Economic Development (OCDE), which implied monitoring and travelling to Paris during four years, as well as going to international events organized by the OECD in Paris, Istanbul and London.

## Public Policy

Designing, developing, applying, and monitoring actions to implement public policy in human rights.

The conceptualization, coordination and execution of the Human Rights Diagnosis and Program in Mexico City stand out for being unprecedented. This initiative was led by the CDHDF and the UN High Commissioner for Human Rights Office in Mexico, with the participation of the Government, the Legislative Assembly and Mexico City's High Court of Justice, as well as universities and NGOs. This exercise culminated with the operation of indicators to design the Federal Budget with a human rights approach and with a law that assures with its application a State Vision.

In addition, under the international standards, more than 20 special reports were elaborated—diagnosis documentation about specific themes that detects structural aspects on the violation of human rights and hold recommendations that propose public policies to bring about government and social action towards their eradication. Amongst these reports, the following stand out: Human Right Violation Towards a Healthy and Ecologically-balanced Environment by Deterioration and Disappearance of the Conservation Land (2005), Sexual Commercial Exploitation of Children (2006), Indigenous People's Rights Living in Mexico City (2007), the Right to Health Protection of People Living with HIV (2008), Human Safety (2008), The Human Rights Situation of Persons with Disabilities (2008), and The Condition of

Mexico City's Police (2009). Furthermore, eight additional annual reports and four special reports on the status of women's human rights were also presented.
