SERVICES RENDERED TO THE INTERNATIONAL COMMUNITY

. Independent Expert Member of the United Nations Committee on Economic, Social and Cultural Rights (CESCR/UN) from January 1 - 2010, to December 31 - 2022, serving as Chair from 2019 to 2021.

In 2009, the Brazilian State presented its candidacy to the United Nations Committee on Economic, Social and Cultural Rights (CESCR). Elected and re-elected twice, between 1/1/2010 and 31/12/2022, as one of its 18 independent experts, serving as chair from 2019 to 2021. Therefore, in the CESCR were twelve years of international experience in the Economic, Social, Cultural and Ambiental Rights (ESCAR), having participated as rapporteur and working group for all Latin American countries that are States Parties to the International Covenant on Economic, Social and Cultural Rights (ICESCR). A work involved in a critical and deep analysis capacity, because in addition to official reports and statistics, the CESCR also receives information from the organized civil society. In addition to examining reports, recommending judicial and public policy actions to affirm and guarantee the rights contained in the ICESCR, there is already in force its Optional Protocol, which grants the Committee the power to receive and examine individual complaints from people who report potential violations of the rights protected by the ICESCR. As a member, it actively participated in the development and approval of the first rules of procedure of this Protocol and in the pioneering Working Group for the analysis of individual complaints. The CESCR also publishes its interpretation of the provisions of the ICESCR, known as General Comments. Therefore, it is a work of high technical and political capacity and responsibility in the CESCR, which has forged a deep and recent expertise on the internalization and protection of ESCR, with notorious attention and expertise in the Americas.

As country rapporteur, he was responsible for the analysis of official State reports, particularly in relation to the domestic implementation of the ICESCR in the States Parties: the fight against poverty; the right to a healthy environment and the challenges of climate change; the right to basic sanitation; the right to adequate housing; Articles 6 (right to work); 7 (right to just and favorable conditions of work); 8 (right to form and join trade unions); 9 (right to social security and social insurance); 11 (right to an adequate standard of living); 12 (right to the highest attainable standard of physical and mental health); 13 (right to education) and 15 (right to culture) of the ICESCR. Especially on these rights, he led the constructive dialogue with the States Parties and prepared the Committee's proposals with concerns and recommendations, also suggesting public policies, for their affirmation and achievement. In relation to the countries covered by the rapporteurship now in nomination, he maintained rapprochement and constructive dialogue with all Latin American countries that have been presented from 2010 to December 2022, in addition to having been rapporteur or participating in the working group on these States Parties. Therefore, about ESCAR he has an updated and deep analysis practice with respect to the countries covered by that vacancy. On those countries, he is fully qualified to analyze, disseminate information and materials, propose strategic actions and work legally on individual complaints on current and historically recurrent issues of poverty alleviation; environmental



protection; climate change; gender equality; adequate standard of living; protection of indigenous peoples; protection of families; right to education; discrimination against Afro-descendants; discrimination against the LGBTQI+ community; protection of human rights defenders; protection of migrants, refugees and asylum seekers; socio-economic policy and labor rights. It will also discuss the protection of the right to organize, and knowledge-sharing activities aimed at improving awareness and understanding of the changing and evolving world of work and shaping measures that address the four pillars of Decent Work (employment, social protection, social dialogue, and rights at work) in line with recent information and as a result of constructive dialogue with these countries.

It should be noted that he was the rapporteur for the 2016 **Declaration of the Committee on Human Rights Defenders and Economic, Social and Cultural Rights**; as well as joint rapporteur for its **General Comment No. 23, of 2016, on the Right to Just and Satisfactory Conditions of Work (article 7 of the Covenant)**. It is, therefore, 12 years not only of analysis, but also of qualified doctrinal and theoretical contribution on ESC rights to the States Parties. Finally, he has already been twice Vice-Chairman and Chairman of the Committee (between 2019 and 2021). During his presidency, the CESCR adopted two important declarations, one on "**the pandemic of coronavirus disease (COVID-19) and economic, social and cultural rights**" and the other on "**universal and equitable access to vaccines against coronavirus disease (COVID-19)**". Two strong statements were also adopted: "**The promise to leave no one behind: the International Covenant on Economic, Social and Cultural Rights, and the 2030 Agenda for Sustainable Development. Declaration of the Committee on Economic, Social and Cultural Rights 2019**"; and the "**Declaration on Freedom of Association, including the right to form and join trade unions. Joint Statement of the Committee on Economic, Social and Cultural Rights and the Human Rights Committee 2019**". In these documents, the Committee highlights the challenge posed by the current moment of confronting the coronavirus and the challenges arising from the COVID-19 pandemic for the affirmation of ESC rights. These rights will be better protected in a framework of cooperation, especially between countries, but also between important actors of civil society and international organizations. The recent and updated discussions between the CESCR, the various and varied specialists in this field and the States Parties, exposing the ESCAR in the face of the sensitive and challenging reality of the COVID-19 pandemic, will greatly contribute to the exercise of this vacancy in the midst of this devastating reality. Finally, as a member of the CESCR, many documents of various international organizations and bodies have been relevant as promoters and paradigms of its functions, which will allow him to contribute to this vacancy with a broad, comparative, diverse and plural normative and protective vision based on the three aspects of the international protection of the human person (law of armed conflict, human rights, and refugee law). He also participated in important events on the right to health at the invitation of the World Health Organization/Pan American Health Organization (WHO/PAHO) through its Washington Office.

In addition, in his 12 years as an expert member of the CESCR between January 1, 2010 and December 31, 2022, he actively participated in the content discussions, documentary analysis, drafting and adoption of the following general comments: **General Comment no. 25 (2020), on science and economic, social and cultural rights (article 15, paragraphs 1(b), 2, 3 and 4, of the International Covenant on Economic, Social and Cultural Rights)**; **General Comment No. 24 (2017) on States' obligations under the International Covenant on Economic, Social and Cultural**
